The Van Buren County Board of Supervisors met on this date at the courthouse with supervisors Meek, Nixon, and Waugh present. County attorney Abe Watkins was also present. Minutes of the previous meeting were acknowledged.

Randy Besick and Chuck Lazenby, Keosauqua, were present to raise various concerns about the proposed county social host ordinance. County attorney Watkins raised concerns about the absence of the option of filing a criminal penalty in place of or in addition to the civil penalty proposed in the ordinance.

Pathfinders R, C, & D executive director Anna Bruen was present to update the board on programs administered thru Pathfinders R, C, & D.

Keosauqua city clerk Joy Padget, Mayor Nasseem Hesler and two city council members were present to update the board on grant funding for the Ferguson Sports Complex in Keosauqua and funding/letter of support request for the same. Following discussion, it was moved by Nixon, seconded by Waugh that the chair be authorized to sign a letter of support for consideration of additional funding for this project. Ayes: 3

County Engineer Ryne Thornburg was present to update the board on various road projects including bridge projects in Lick Creek and Village Townships, J40 asphalt overlay between Bonaparte and Bentonsport, road crew work accomplished and proposed, job opening, old Kilbourn Bridge potential removal, entrance permit policy, upcoming meetings, V64 plans, and county line agreements.

On motion by Nixon, seconded by Waugh, the board approved, pending receipt from the contractor, the final pay voucher on the W40 asphalt resurfacing project north of Bonaparte. Ayes: 3
